Authorized dealers allow a minimum three-day decision-making window, where you can decide to keep or return the car. Please note, some authorized dealerships may have restrictions that void the return period. **Within 14 days after the return period for your replacement vehicle has expired, you must return to the dismantler for a Post-Inspection and to scrap your old vehicle.** You must return to the same dismantler where you had your Pre-Inspection performed.
