18 to consider Respondent Martin Marietta Materials’ unopposed request to extend the final
19 compliance deadline (currently October 31, 2025) in the Conditional Order for Abatement filed on
20 April 24, 2024) to October 31, 2026. This matter will be heard on the Hearing Board agenda’s
21 Consent Calendar.

22 The Hearing Board members are required to attend in person, but the parties and members of the

2 **date, if they wish to participate via Zoom.**

3 You may be, but need not be, represented by counsel. You may present any relevant evidence
4 and will be given full opportunity to cross-examine all testifying witnesses. You are entitled to the
5 issuance of subpoenas to compel the attendance of witnesses and the production of books, documents,
6 and other things by applying to the Clerk of the Boards.

7 The proceedings of the hearing will be electronically recorded, copies of which will be made
8 available to the parties upon request and payment of records duplication fees. Should either party
9 desire the services of a court reporter, with the cost to be borne by the requesting party, please contact
10 the Clerk of the Boards as soon as possible and, in any event, no later than ten calendar days prior to
11 the date of the hearing, pursuant to Hearing Board Rules § 5.4 (b)(2).

12 **If either party determines that a continuance is necessary, a written request, including**
13 **specific reasons for the request, should be made to the Clerk of the Boards at least four business**
14 **days prior to the hearing date, pursuant to Hearing Board Rules § 15.13**


